Welcome back!

We hope that you enjoyed a good break and wish you a very happy and successful 2016. It's the time of the year again when it's natural to review last year and, looking back, we certainly have had a busy 2015 and are looking forward to an even busier new year!

42 schools in 17 UK Local authorities achieved either a first assessment, or were reassessed, during the Summer and Autumn terms last year – see roll of honour later in the newsletter for more detail.

Other programme highlights included;

- The Investors in Pupils programme handbook has been comprehensively revised in light of the latest Ofsted Common Inspection Framework (September 2015) reflecting the new 'personal development, behaviour and welfare' judgement to remain relevant and fit for purpose.
- A welcome development saw School/Student Councils highlighted as examples of practical actions schools can take to contribute to 'Promoting fundamental British values as part of SMSC in schools' (DfE 2014) ensuring *"that all pupils within the school have a voice that is listened to, and demonstrate how democracy works by actively promoting democratic processes such as a school council whose members are voted for by the pupils"* and talking of pupil voice
- Investors in Pupils partner schools hosted a number of successful open mornings at various locations including, notably, West Bretton Junior and Infant school who performed a rendition of their very own pupil voice anthem 'Give us a voice'. Take a look at <http://youtu.be/zlbZNk9nst8>

Introducing a new Investors in Pupils Reaccreditation process...

A new reaccreditation pathway, designed through consultation with a range of schools, was successfully piloted in partner schools over the spring and summer terms last year. As a result, from September 2016, ***all*** schools submitting for reaccreditation will be required to integrate an enhanced role for pupils/students into the visit. In practise this means pupils having more of a pro-active role both on the reassessment day as well as in preparation for the day itself including a role in contributing to the school's self-review application.

From September, as a compulsory part of reassessment, pupils will be expected to design and deliver a presentation that illustrates how they have been informed/consulted/involved or influenced a whole school project that has made a positive impact in school contributing to overall school improvement. The specific focus for the presentation is the schools choice and the Assessor will look to establish a strong evidence base that has informed this selection including any data used. The project may be partly, though should be almost, complete and the following provides some examples of possible topic areas from pupil's work in other schools;

- school curriculum - teaching & learning (the way pupils learn)
- pupils personal development, behaviour and welfare
- school policy review and development
- school environment - buildings and grounds
- community/local and global
- lunch and playtimes - meal times/school food
- issues raised through pupil consultation, school/student council, etc, and
- democracy & citizenship - British Values; mutual respect and tolerance

Following a presentation (15-20 mins) pupils should be prepared to answer Assessors' questions. Use of photographs, charts, videos and any other creative ways of demonstrating what has been done in school are encouraged.

Introducing a new framework for secondary schools...

Although retaining the existing 'Investors in Pupils' name, our work with secondary schools and students is currently being reviewed and, in particular, the framework for secondary schools which is to be increasingly tailored to meet their specific needs of secondary schools. As with the introduction of the new reaccreditation pathway this development comes into effect from September 2016.

Numerous open events – don't miss out!

In recent years we have held a number of successful open events and this year we will be continuing this trend. Already we have some open mornings fast approaching in Tameside and West Yorkshire. These are still open for colleagues to book onto but you will need to book quickly to ensure that you don't miss out on these fantastic opportunities. Popular with schools, colleagues tell us that it's a really good way to gain new ideas and to see how Investors in Pupils works in practice in a school.
